\$220 for first 40 units; Additional \$1 for each unit over 40

12. Associate Memberships

An individual person in a professional corporation such as insurance or real estate may purchase an Associate Membership for \$105 per year as long as the principal firm retains membership. Each Associate Member will receive all regular membership benefits.

13. Retirees & Non-Employed Individuals

Any retired person or unemployed individual may obtain a membership for \$105 per year and be eligible for full membership benefits. The \$25 processing fee does not apply for retired persons.

14. Home Based Businesses

\$157 per year; business must be located in owner's primary residence.
